
The Emancipation Proclamation and 13th Amendment

- Lincoln first offered compensated emancipation plus colonization
- Emancipation Proclamation was military measure to free slaves, recruit blacks for Union
- Lincoln supported 13th Amendment, which abolished slavery


The 14th Amendment's Equal Protection Clause



- “No State shall . . . deny to any person within its jurisdiction the *equal protection of the laws*”
- Meant government could not unreasonably discriminate
- Courts applied “rational basis test” or “strict scrutiny test”

Reconstruction's Rise and Fall

- Reconstruction collapsed in 1877
- “I here and now denounce his so-called emancipation as a stupendous fraud . . . a fraud upon the world”
– Frederick Douglass,
1889

Plessy v. Ferguson (1896)

- Supreme Court upheld La. Law requiring segregation in rail coaches
- Court created “separate-but-equal” doctrine
- Ruled separate facilities for African Americans and whites were constitutional under Equal Protection Clause

Jim Crow and Lynchings

- By late 1800s, nearly half of states passed Jim Crow laws requiring segregation of races

Brown v. Board of Education (1954)

- Supreme Court declared separate public schools for whites and blacks “inherently unequal” and violated Equal Protection Clause
- Court ordered states to promptly end segregation “with all deliberate speed”
